<u>Discuss Grant Research and other Funding</u>: Mona offered the use of the Senior Citizen's manager's office computer to look at the Grant Watch program which they own in order to locate grants that may be applicable and available for our work. Mona said that to look for smaller grants for a piece by piece approach would be more likely to be successful.

## **New Business:**

Review the progress on the Woolen Brown building since May: The Commission toured the building and discussed the work that has been done and especially all the volunteer labor that Roger has contributed this summer. It is very encouraging and impressiv to be making steady and sure progress in demolition of accretions. The removal of the sheet rock and insulation in the window spaces which Roger has done reveals more of the sense of the original feel of the rooms with such large windows and high ceilings. Althea and Patty worked on July 21st clearing out the first room for the Senior Citizens to use to store stuff and also moved all the Senior Citizens boxes etc that were in the entry area. On July 22 Althea talked to Mona and Mona agreed to have all the Senior Citizens' items moved into the first room but not in the entry so it will all be as close to the door as possible without blocking the entry. Also Althea and Brad Sondahl and Patty Murphy and Becky Demers moved and cleaned up and Becky hauled away garbage from Roger's work on July 25.

Review Senior Citizens' use of the Building The Seniors will move the stuff in the entry which was put in it as soon as Althea and Patty had cleared the stuff that was there before. Also the Althea reminded the group that the Seniors has agreed to work on the building in return for the use of a room.
