Mayor Eastman called the meeting to order at 6:31 p.m.; roll call was taken with Councilors Becki Gaddum, Darrell Woods, and Jeremy Cowperthwaite present. Councilor Gary Ventress appeared by phone.

Roll call was followed by the Pledge of Allegiance.

Emergency Amendment to the Agenda- Attorney, Chris Gabbert, explained the purpose of the amendment to the agenda was to add in new business, the appointment of Shanna Swalander to the vacant City Council seat. State Code 74-204 4C - the amendment is due to concern of a lack of quorum and not being able to do business. The emergency amendment was approved in a motion by Councilor Cowperthwaite, second by Councilor Gaddum, followed by a roll call vote with Councilors Ventress, Gaddum, Woods, and Cowperthwaite all voting aye - motion passed.

- Approve Appointment of Shanna Swalander to the Vacant City Council Seat- approved in a motion by Councilor Woods, second by Councilor Privitt, followed by a roll call vote with Councilors Ventress, Privitt, and Woods all voting aye - motion passed
- b. Elect the Council President Mark Privitt was elected the Council President in a motion by Councilor Woods, second by Councilor Swalander, followed by a roll vote with Councilor

Ventress abstained, Councilors Privitt, Woods, and Swalander voting aye. - motion passed. At 6:45 PM Councilor Ventress excused himself from the meeting.

- c. Anne Wescott -Presentation on The Spirit Lake Impact Fee Advisory Committee, Interlocal Agreement between the City and the Fire District, and the Interlocal Agreement between the City and KCEMSS City Attorney, Chris Gabbert, explained this is a proposal for a fire impact fee advisory committee and was approved by the previous Council. Anne Wescott shared the findings of the committee. The impact fee is a one-time fee on new growth. Impact fees are designed to ensure that levels of service do not decrease with growth, not to make the level of service better. Proposed \$1725.00 fire impact fee and \$132 for EMS per new residential dwelling unit. Councilor Woods stated the numbers do not add up and noted we pay high taxes in the district. Expressed concern that the costs were too cheap for the equipment. Discussion with the Fire Chief, John DeBernardi, about the current and projected costs.

 The City Attorney, Chris Gabbert, recommend moving forward and is reviewing the Intergovernmental Agreement.
