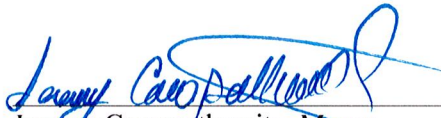
Old Business:

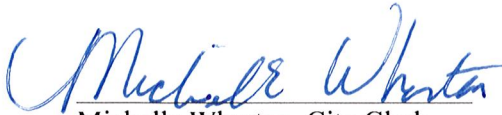
New Business:

- a. Approve FY 20/21 Draft Audit – Toni Hackwith with Anderson Bros gave a brief presentation of the FY20/21 Audit. Page #7 was noted- the Balance Sheet- Fund Balance was \$78,000 at the end of year. Page #9 was noted. Toni stated the loss was due to timing and the timing of capital projects. It was also noted that the streets impacted the budget by \$136,000 due to projects being completed and the funds used (work completed in September- paid later in next year). Pages #11 and #12 were noted- Water and Sewer fund. Page #36 is the final report- No compliance issues. Councilor Swalander made a motion to approve the 20/21 draft audit, second by Councilor Ventress followed by a roll call vote with Councilors Swalander, Woods Ventress all voting aye - motion passed.
- b. Approve Professional Services Contract between City of Spirit Lake and Panhandle Area Council for Project Development and Administration – Three Year Period. Approve Mayor Cowperthwaite to sign- Councilor Woods made a motion to allow Mayor Cowperthwaite to take care of the paperwork, second by Councilor Swalander followed by a roll call vote with Councilors Swalander, Woods Ventress all voting aye - motion passed.
- c. Approve Task Order #1 Professional Services Contract between City of Spirit Lake and Panhandle Area Council. Approve Mayor Cowperthwaite to sign- Councilor Swalander made a motion to Approve Task Order #1 Professional Services Contract between City of Spirit Lake and Panhandle Area Council, second by Councilor Ventress followed by a roll call vote with Councilors Swalander, Woods Ventress all voting aye - motion passed.
